

Type of information we collect:

We receive, collect and store any information you enter on our website or provide to us in any other way. In addition, we collect the Internet Protocol (IP) address used to connect your computer to the Internet; login; email address; password; computer information; and connection and purchase history. We may use software tools to measure and collect session information, including page response times, duration of page visits, information on the interaction between the pages, and the methods used to navigate outside the page. We also collect personal identification information (including name, email address, password, and communications); payment details (including credit card information), comments, reactions, product evaluations, recommendations, and personal profiles.

How do we collect information?

When you make a transaction on our website, as part of the process, we collect the personal information you give us, such as your name, address, and email address. Your personal information will only be used for the specific reasons mentioned above.

Why do we collect such personal information?

We collect this non-personal and personal information for the following purposes:

1. Provide and operate services.
2. Provide our users with permanent Support and technical support.
3. To be able to contact our visitors and users with general or personalized opinions about the service and promotional messages.
4. To create aggregated statistical data and other aggregated and/or inferred non-personal information, which we or our business partners may use to provide and improve our respective services.
5. Comply with applicable laws and regulations.

How do we store, use, share and disclose visitors' personal information to our site?

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform to sell you our products and services. Your data can be stored through Wix.com's data storage, databases, and general applications. They store your data on secure servers behind a firewall.

All direct payment gateways offered by Wix.com and used by our company meet the standards established by PCI-DSS, as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express, and Discover. The PCI-DSS requirements ensure that our store and its service providers process credit card information securely.
